

## MCF 2027 FESTIVAL TOOLKIT

## TK05 - SETTING UP A REGULAR PAYMENT PLAN USING A PAPER FORM

A Regular Payment Plan (RPP) is a commitment by the donor to pay a regular amount each month for a set period. The advantage of this method is that for a small amount, E.g. £15.00 per month over 3 years\*, the donor can qualify as a Festival Steward.

Payment is usually made by Direct Debit. If it is made by Standing Order, then the brother does not qualify until all donations have been received. This is because MCF do not see the details of a Standing Order in the same way as a Direct Debit.

## **Changing the RPP**

Cancellation - If a brother falls on hard times, he can cancel the RPP without penalty

**Amendment** – the term of an RPP can be varied, made either shorter or longer, but the monthly amount can only be decreased. If the donor wishes to increase the monthly amount, then a second RPP should be taken out for the amount of the monthly increase.

**Multiple RPPs** – a donor can take out as many RPPs as they wish. However, a RPP can only be credited to the honorifics of one lodge. If a brother belongs to two or more lodges, and wishes to contribute to the honorifics of each of them, he needs to take out an RPP for each lodge. His qualification as a Festival Steward, or higher honorific, is based on the total of all his RPPs.
