There are three ways for an individual to make a single donation depending upon how the payment will be made

- Cash
- Cheque
- Credit Card

Making A Donation By Cash

The only way to do this is using a Gift Aid Envelope which can be obtained from your lodge Charity Steward who can also advise you on how to complete it if required
