



MCF 2027 FESTIVAL TOOLKIT

TK10 - TRANSFERRING MONEY FROM A RELIEF CHEST TO THE FESTIVAL

There are three main different types of Relief Chest

- 1) Festival Relief Chest (MCF2027)
- 2) Lodge Relief Chest
- 3) Individual Relief Chest

Festival Relief Chest (MCF2027)

This is the Relief Chest into which donations and payments from Regular Payment Plans are deposited. It is controlled by the MCF.

Monies paid into this Relief Chest can attract Gift Aid Tax Relief if the donor is a qualified UK Taxpayer.

It is from this Relief Chest that the MCF 2027 Festival Provincial team receive information regarding qualification by Brethren as a Festival Steward, Vice Patron, Patron and Grand Patron and also lodges qualifying for a Bronze, Silver, Gold or platinum Award

Lodge Relief Chest

This is the Relief Chest into which donations and payments can be made by members of the lodge. It is controlled by the lodge and there is a nominated representative of the lodge who administers it and can action payments from it in accordance with resolution of the lodge.

Monies paid into this Relief Chest can attract Gift Aid Tax Relief if the donor is a qualified UK Taxpayer.

It should be noted that once a brother has paid money into a lodge Relief Chest, payments from it are controlled by ALL members of the lodge, not just those who have contributed. Donations from this type of Relief Chest are made by resolution in open lodge.

No Notice of Motion is required for the lodge to consider a resolution to make a payment from the lodge Relief Chest.

Payments made from this relief chest to the Festival Relief Chest are usually pro-rated to the honorifics of those brethren who have made contributions to it.

An example of how this can be done is as follows

Over a given period (e.g., since the last festival) a total of £3,000 has been credited, of which £2,000 has been donated to charities.

The lodge has agreed to transfer the remaining £1,000 to the MCF 2027 Festival.

During the period in question the following brethren have made these donations

Brother A - £300

Brother B - £750

Brother C - £1500

Brother D - £400

Based on these brethren will credited with the following amounts against their honorifics

Brother A – $£300 \times £1,000 / £3,000 = \underline{\underline{£100}}$

Brother B - $£750 \times £1,000 / £3,000 = \underline{\underline{£250}}$

Brother C - $£1500 \times £1,000 / £3,000 = \underline{\underline{£500}}$

Brother D - $£400 \times £1,000 / £3,000 = \underline{\underline{£150}}$

Individual Relief Chest

This is a Relief Chest into which an individual brother makes donations and payments. It is controlled by him. He can make payments from it as he wishes subject to the rules of the Relief Chest Scheme which will almost always be to a Registered Charity.

Monies paid into this Relief Chest can attract Gift Aid Tax Relief if the donor is a qualified UK Taxpayer.

The brother controls all aspects of it

Making a Payment

Payments can be made from a Lodge or Individual Relief Chest either by generating an e-voucher online or by completing a paper form. The document below gives details of both these methods

Transferring funds to the Festival Relief Chest from a Lodge/Chapter Relief Chest

Funds held in a Relief Chest **can be transferred to a Festival Relief Chest**. Transfer can be made using a Green form or e-voucher. The transfer amount can be allocated to the individual members for honorific purposes. Only complete a Transfer Allocation form if the donation amount is to be allocated to members.

Green Form

- Write Hampshire & Isle of Wight 2027 Festival as the charity name
- Write MCF2027 as the registered charity number
- add amount in numbers and words
- sign the form (Relief Chest representative + another officer)
- post the green form to Relief Chest Scheme
- enclose a transfer allocation form if applicable



e-Voucher

- Register (your name and email address)
- Confirm registration (via email)
- start new voucher
- add payment details

If the donation to be allocated to individuals for honorific purposes, complete the transfer allocation form separately and return to the Relief Chest Scheme.

E-voucher service

Our E-voucher service allows Relief Chest holders to request payments to charities online.
